(No. 1 of 2013)

[23rd April, 2013]

AN ACT to provide protection against sexual harassment of women at workplace and for the prevention and redressal of complaints of sexual harassment and for matters connected therewith or incidental thereto.

Whereas sexual harassment results in violation of the fundamental rights of a woman to equality and non-discrimination; and the Constitution of India and the Fundamental Rights and Directive Principles of State Policy of the Constitution and the International Convention on the Elimination of All Forms of Discrimination Against Women, which has been ratified by India on the 25th August, 1993 by the Government of India;

And whereas the protection against sexual harassment and the right to work with dignity are already well-recognised human rights by international conventions and instruments such as Convention on the Elimination of All Forms of Discrimination Against Women, which has been ratified by India on the 25th August, 1993 by the Government of India;

And whereas it is expedient to make provisions for giving effect to the said Convention for protection of women against sexual harassment at workplace;




